D e c i s i o n

The Ministry of Health of the Slovak Republic (hereinafter referred to as the "Ministry"), as the competent administrative authority in respect of issuing licences under sec. 35(b) of the National Council of the Slovak Republic Act No. 139/1998 Coll. on Narcotic Drugs, Psychotropic Substances and Products, as amended (hereinafter referred to as the "Act"), following the provision of sec. 46 of Act No. 71/1967 Coll. on Administrative Proceedings, as amended (hereinafter referred to as the "Act on Administrative Proceedings"), upon establishing the factual and legal situation, decided as follows:

The licence holder's duties concerning the handling of narcotic drugs and psychotropic substances are specified in the provision of sec. 14 of the Act.

As of the date of this Decision coming into force, the Licence for handling narcotic drugs and psychotropic substances under reg. no. do-OPL-027/20 of 21 December 2020 is revoked.

Justification:

With the letter of 20 October 2021 delivered to the Ministry on 12 November 2021 under no. SFaLP-Z097993/2021/OF, and upon supplementing documents on 16 November 2021, the applicant asked the Ministry for a change of the specialist representatives contained in the Licence for handling narcotic drugs and psychotropic substances, with respect to the company PHOENIX Zdravotnicke zásobovanie, a. s., 831 04 Bratislava, Pribylinská 2/A, CIN: 34 142 941.

Upon reviewing the application and the appendices thereto, the administrative authority established that the applicant fulfilled the statutory conditions pursuant to the provisions of sec. 10(2) in conjunction with sec. 8(1-3) of the Act for a licence to be issued under sec. 9(1)(3) of the Act.

Under sec. 47(1) of the Act on Administrative Proceedings, "a decision must include an operative part, justification and advice on lodging an appeal (remonstrance). Justification is not required if the parties to the proceedings are satisfied to the full extent."
