## DECISION

The State Institute for Drug Control, as the competent public administration authority having subject-matter jurisdiction to act under sec. 5 of Act No. 71/1967 Coll. on Administrative Proceedings, as amended (hereinafter referred to as the “Administrative Procedure Code”) and sec. 129(2)(e) point 6 of Act No. 362/2011 Coll. on Medicinal Products and Medical Devices and on Amendments and Supplements to Certain Laws, as amended (hereinafter referred to as the “Act”), in accordance with the provision of sec. 7(1)(b) point 3 and sec. 8(3) of the Act, within the administrative proceedings concerning an application filed by the applicant, PHOENIX Zdravotnícke zásobovanie, a. s., Pribylinská 2/A, 831 04 Bratislava, Company Ident. No. (CIN): 34 142 941, pursuant to sec. 7(6) of the Act, in conjunction with the provision of sec. 46 et seq. of the Administrative Procedure Code, for the issuance of a licence to handle medicines in wholesale distribution of human medicines, after the required documents having been submitted, decided

The activity commencement day is the day following the day on which this Decision comes into force.

At the same time, the State Institute for Drug Control Decision No. R/394/2020 of 16 December 2020, which came into force on 17 January 2021, Reg. No. D-56/2020/2, whereby the company PHOENIX Zdravotnícke zásobovanie, a. s., Pribylinská 2/A, 831 04 Bratislava, CIN: 34 142 941, was allowed handling medicines in wholesale distribution of human medicines, is revoked.

**Justification:**

Upon reviewing the application of 26 October 2021 filed by the applicant, PHOENIX Zdravotnícke zásobovanie, a. s., Pribylinská 2/A, 831 04 Bratislava, CIN: 34 142 941, registered by the State Institute for Drug Control under no. 7337/2021/621, for the issuance of a licence to handle medicines in wholesale distribution of human medicines due to a change in the persons of specialist representatives, the administrative authority states that the applicant has fulfilled the statutory conditions for a licence to be issued under the provisions of sec. 3, 4, 5, 6, and 8(3) of the Act. Based on the facts mentioned above, the administrative authority has decided as given in the operative part hereof.

The conditions and duties applying to the holder of a licence for wholesale distribution of human medicines are laid down in the provisions of sec. 17, 18, and 74a of the Act.

**Advice:**

It is possible to lodge an appeal against this Decision under sec. 53 et seq. of the Administrative Procedure Code. Under sec. 54 of the Administrative Procedure Code, appeals are to be lodged with the administrative authority issuing the contested decision. An appeal must be lodged with the State Institute for Drug Control within 15 days following the date on which this Decision is notified.

Upon becoming final as a result of exercising an ordinary remedial measure, this Decision is reviewable by the court pursuant to Act No. 162/2015 Coll. the Code of Administrative Court Procedure.
